

NOTIFICATION OF TREASURY SHARE BUYBACK

BETWEEN 30 NOVEMBER – 4 DICEMBRE 2020

Within the buyback plan (the “Plan”) – as communicated on 30 April 2020 and launched on 15 May 2020, in compliance with the resolution passed by the Shareholders’ Meeting held on 30 April 2020 – Fine Foods & Pharmaceuticals N.T.M. S.p.A. announces that between 30 NOVEMBER and 4 DICEMBRE 2020 it bought back, on the AIM Italia market (AIM) managed by Borsa Italiana, no. 11,897 treasury shares (corresponding to 0.0505% of the Company’s share capital) at an average price of Euro 10.9993 per share for a total amount of Euro 130,859.

On the basis of the information given by Banca Akros – the appointed intermediary to manage the Plan in full autonomy and independence – here above are the details of the transactions on a daily basis:
