S.p.A. as part of its treasury share buyback programme (the Programme) – which was announced to the market on 21 April 2021 and launched on 21 April 2021 implementing the 21 April 2021 Shareholders' Meeting resolution - in the 28 FEBRUARY – 4 MARCH 2022 period, purchased 500 treasury shares, (equal to 0.0020% of the share capital), at an average weighted price of  $\notin$  11.6461, for a total value of  $\notin$  5,823.06.

The buyback was made through the intermediary Banca Akros, LEI Code 549300GRXFI7D6PNEA68.
